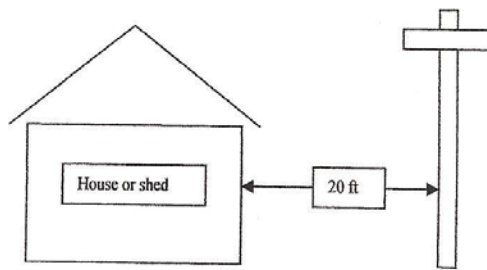

20ft from utility pole line

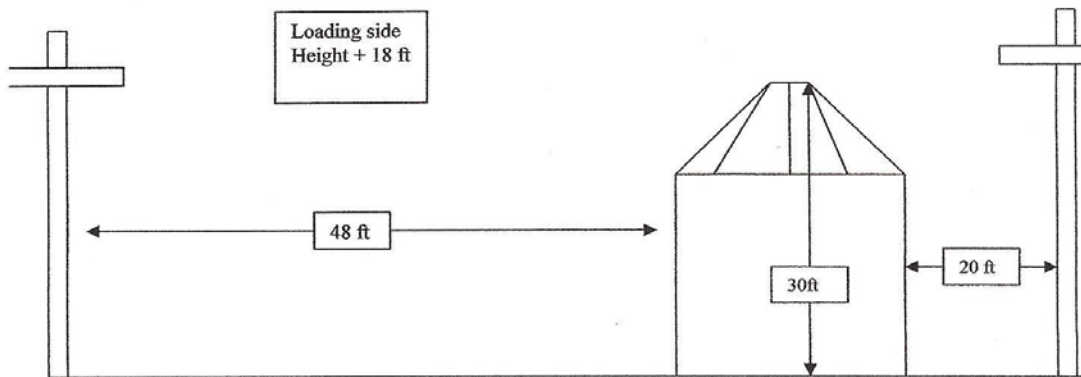


Grain Bin Construction

On Non-loading side of grain bins—20ft from utility pole

On Loading side of grain bins—18ft + Total Height of bin



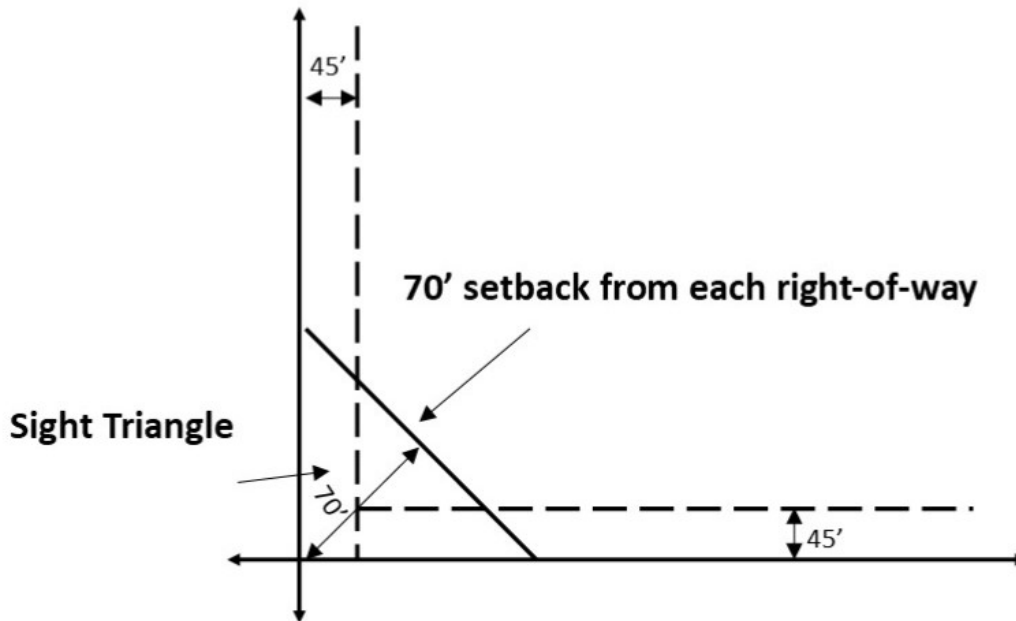
Howard County Setback from Intersections

All road intersections

Yard regulations in each category

Example in A1, page 105: Seventy (70) feet from the right-of-way at intersections. This forms a sight triangle which has the 70' point in the middle of the hypotenuse of an isosceles triangle (two equal sides) formed by the forty-five (45) foot setback and the hypotenuse.

35' setback require a 60' line of site setback
25' setback require a 50' line of site setback.



NOTICE

In accordance with Nebraska State statutes governing electrical licensing and inspections known as the Nebraska State Electrical Act, Sections 81-2101 through 81-2144, footings for new construction are required to be inspected by the state electrical inspector prior to being poured. A rough-in inspection is required before any wiring is to be covered by building walls, ceilings or floors. Failure to request the inspection may result in removal of the covering to make an inspection possible. Inspection is required on all new wiring installed for single-family residential application when new service equipment is installed. This is a requirement statewide, inside or outside of the city or village limits. Any building materials and/or waste from building materials must be disposed of on owner's property. Examples would be but not limited to, concrete wash-out, excess insulation, siding, ect. **Waste will be considered littering and fines will be issued.**

Must have approval from Howard County Roads Department to put in a new driveway.

Must have approval from Howard Co. Commissioners and Howard Co. Roads to build a home on a minimum maintenance road.

Easements: Must have approval to build, drive over any access / road / utility easements. See section of permit for approval. Landowner responsible for any accidents if no approval on file.

Any work done by the river or creek beds, obtain a 404 Permit or letter stating not necessary along with a floodplain permit from Floodplain Administrator.
